When using the 5 litre working standard conical measure during inspection the Maximum Permissible Error (MPE) allowed should be 0.5% positive or negative (or)  $\pm$  25ml.

In continuation of the workshop on Calibration of Tanker Lorries, Fuel and LPG dispensing Units conducted on 12.03.2015 by this office, the Oil Marketing Companies are requested not to suspend the dispensing units if any discrepancy is noticed by the officials of OMCs during their regular inspection of dispensing units. They are requested to contact the Asst. Controllers of Legal Metrology of the respective area and inform them to inspect the unit and if any shortfall is noticed, the Assistant Controllers of Legal Metrology may again calibrate the dispensing unit and issue a fresh verification certificate.

The OMCs are requested to inform about the tower calibrations one week in advance every year to the supply location dealers/TNPDA office bearers and request them to be present during tower calibration for transparency and clean administration.

The OMCs are also requested to deliver right quantity of fuel to the dealers/trucks and the Tanker truck crews may also be allowed to check the quantity of the product that is taken delivery from the OMCs terminals / depots by using the dip rod.

In continuation of the workshop on Calibration of Tanker Lorries, Fuel and LPG dispensing Units conducted on 12.03.2015 by this office, the following instructions are given to the Deputy Inspectors of Labour and they are instructed to strictly adhere to the instructions given.

- 1. While issuing verification certificate for petrol/diesel/LPG dispensing units the Asst. Controller of Legal Metrology are requested to specify the 'K' factor in the verification certificate.
- 2. All terminals in Tamil Nadu may be jointly inspected for its accuracy and correctness by the jurisdiction of IL's & DILs and the present condition of the terminals may be informed to this office to take necessary remedial measure.
- 2. They are instructed to be transparent and verify the 20 Ir. working standard conical measure or newly provided 10 litre field test measure in front of the dealers/terminal officials before it is taken for calibration of tower.
- 3. They are instructed to verify by pouring method and finally verify and show that the Tower is calibrated with maximum accuracy by checking once by withdrawal method at the end of calibration.
- 4. They are instructed to ensure that the seals are intact without leaving any provision for any adjustments in dispensing pumps/calibration towers / tanker trucks /flow meter /weigh bridges etc.
- 5. To avoid rush in calibration of tanker lorries at the end of the quarter, the present system of calibrating the tanker lorries on date basis may be continued.

Subject: Request for Implementation of 'Principle of Transparency' in OMC's Prover Tower Calibration - Trichy IOCL Terminal - Tamil Nadu

Respected Sir,

We are writing on behalf of the Tamil Nadu Petrol Dealers Association [TNPDA] regarding a matter of significant concern related to the implementation of the 'Principle of Transparency' in OMC's 'Prover Tower' Calibration, particularly at the IOCL Trichy Terminal.

We would like to bring to your attention the letter dated 10.10.2023 (1-12/17/2023-W&M) issued by the Ministry of Consumer Affairs, along with the subsequent Round table workshop conducted on 09.06.2023 and the 'DECISION' of the Government of India, Ministry of Consumer Affairs Food & Public Distribution, Krishi Bhavan, New Delhi-110001, dated 07.08.2023. These directives were issued in compliance with the Orders dated 30.05.2023 of the Honourable High Court Judicature for Rajasthan at Jodhpur in S.B. Civil Writ Petition No.7860/2023 titled M/s. Vinayak Fuel Filling Station Vs. UOI & others.

The Ministry's initiative aims to bring transparency to OMC's Terminal calibration processes, and a Standard Operating Procedure (SOP) has been formulated as a result of the workshop. The SOP is intended to be implemented nationwide by OMCs, OEMs, and Controllers of all the States.

However, we have observed certain discrepancies at the Trichy IOCL Terminal, particularly regarding the annual 'Prover Vessel' calibration due in the December quarter. Unfortunately, there has been a lack of communication to the Industry State Association, specifically the Tamil Nadu Petroleum Dealers Association, about the

'Prover Vessel' calibration from IOCL Trichy Terminal. The delay in conducting the calibration is adversely affecting the stamping of Dealer Tank Lorries.

Last year, during the Trichy Tower calibration on 14<sup>th</sup>, 15<sup>th</sup>, 16th and 17<sup>th</sup> Nov-22, we observed a significant variation compared to the previous year's calibration. There was a shortfall of 25 liters in the tower for a 12 KL tank lorry. Enclosed, please find the minutes of the Tower calibration conducted last year for your reference.

Furthermore, IOCL Trichy Terminal has directed all Dealer Tank Lorries to get calibrated at Asanur IOCL Terminal, located 130 KM away from Trichy Terminal. This arrangement is causing an additional financial burden of Rs 10,000 for every Dealer Tank Lorry. Additionally, the selective invitation of dealers to witness the annual 'Prover Vessel' calibration is a clear violation of the SOP issued by the Ministry of Consumer Affairs.

In light of the above, we kindly request your intervention to advise IOCL Trichy Terminal to expedite the 'Prover Vessel' calibration to avoid unnecessary expenses for Dealers and ensure compliance with the SOP of the Ministry of Consumer Affairs.

We request you sir to intervene in this matter and anticipate positive action for the benefit of all stakeholders involved.

Kindly refer the 'Round Table Workshop' on 'Measurement of Petroleum Products' and related issues held at Vigyan Bhawan, New Delhi on 09.06.2023 under the Chairmanship of Shri Rohit Kumar Singh, Secretary, Department of Consumer Affairs to improve transparency and simplify the business operations within the realm of Legal Metrology.

2. During the meeting, the issue of calibration of depot towers was raised and it was decided that an SoP will be prepared by the Petroleum Dealers Association. A copy of the SoP submitted by Petroleum Dealers Association is enclosed herewith for needful.

3. It was also clarified by Petroleum Dealers Associations that the OMC's are the owners of Outfits and Equipment installed at Retail Outlets. It was requested that the existing procedure of 'Payment and Reimbursement' of Stamping fees may be discontinued due to delay in reimbursement of such fees. The Associations informed that the amount of stamping fees is considerably huge and the Dealers have to struggle to pay the same at the last minute. At the same time the Legal Metrology officers are also put to inconvenience while planning their visits to carry out the verification.

4. In the meeting it was requested that the OMC's may directly deposit the 'Stamping Fees' in advance for each of the quarter to Legal Metrology Department so that the Legal Metrology Department can plan their schedule of visits to Retail Outlets. It would also prove to be a time saving methodology for Legal Metrology Department.

5. It was suggested to initiate the said system as a 'Pilot Project' in the State of Tamil Nadu, as the database of the new online system has already been installed in Tamil Nadu and is functioning well. In this prevailing database formulated by LM Department of Tamil Nadu, no major modification is required, which may be done by the Government of Tamil Nadu. However, the updating of database in other State

may also be initiated and on its success in Tamil Nadu, the same may be implemented in other States.

Therefore, it is requested that the OMCs may initiate the process of depositing 6. the verification fee online in the State of Tamil Nadu as a Pilot Project.

(g) measurement of petroleum products of tank lorries at Depot with the same technology/ device (flow meter/ dip rod) which is used for decantation at ROs

(h) consideration of verification of ATGs at ROs to cross check the stock in underground tanks

(i) to issue a guideline for use of standard LPG/ CNG testing kits

(j) the accuracy of tank lorry is 0.05% whereas proving measures used for calibration of tank lorries have accuracy of the order of 1%, which may be corrected.

(k) for under ground tanks (UGT) at ROs the stock variation may be 4 % of tank capacity for variation; calibration of underground tanks with latest technology is required.

(vii) Formation of a committee underscores the government's commitment to addressing the issues raised during the workshop under the chairmanship of Joint Secretary (CA). By bringing together key stakeholders such as OMCs, CLMs, OEMs and Petroleum Dealers Associations, the committee aims to develop comprehensive solutions that will enhance the operational transparency and efficiency of the petroleum products industry. The committee will examine all the pending issues illustrated above and submit it's recommendations within 3 months.

During the workshop, several crucial issues were discussed in depth, including tower calibration at terminals, tank lorry calibration carrying petroleum products, "k" factor of dispensing units, verification fees paid to the Legal Metrology Departments for verification/ stamping of dispensing units, product delivery at standard temperatures, calibration of underground tanks at retail outlets, rounding off decimal digits of dispensing units, sealing of pulsar pumps and fuel tank capacity approximation of vehicles.

6. A notable outcome of the workshop was the decision to constitute a committee under the chairmanship of Joint Secretary (CA) with OMCs, OEMs, CLMs and Petroleum Dealers Associations. The committee is tasked with discussing pending issues in detail and recommending solutions that safeguard consumer interests at large.

7. Following Resolutions were adopted during the meeting:

(i) Before calibration of Depot towers, the OMCs will notify the Petroleum Dealers Associations in advance to be present as witnesses to ensure transparency. An SOP may be prepared by Petroleum Dealers Association by 30.6.2023 to be vetted by OMCs before release.

(ii) Legal Metrology officers shall mention the "k" factor of the dispensing unit in the verification certificate to provide an extra layer of assurance about the dispenser's performance. This "k" factor is a critical number that helps in understanding the flow rate or efficiency of a fuel dispenser.

(iii) Invoices issued by OMCs for tank lorries will mention the oil temperature on real time basis and compensate it with the reference temperature of 15<sup>o</sup> C. This is important because the volume of oil can change with temperature. The MPE for Vehicle Tank compartment is 0.05 Percent in Excess of the Marked Capacity of the compartment as per the Legal Metrology (General) Rules, 2011.

(iv) Automobile manufacturers to mention the safe filling capacity instead of the maximum filling capacity, which will help customers to make informed decisions and promote efficiency.

(v) The correct/ full ambient temperature range of operation/ use of dispensing unit shall be mentioned on dispensing units by OEMs.

As you are aware, there are large number of dispensing units installed at Petrol Pumps/ Retail Outlets for delivery of petrol/ diesel/ petroleum products. These dispensing units are periodically verified and stamped by the Legal Metrology Departments of the State Governments to ensure their accuracy.

2 In this regard, I would like to bring to your notice that various Petroleum Dealers Associations have represented to this department stating difficulties faced by them viz. payment of verification fees of dispensing units by OMCs, calibration of underground storage tanks/ tank lorries and adoption of uniform procedure for calibration of towers used for tank lorries calibration etc. A copy of the representations received is enclosed herewith for kind information

In their representations and also in the meetings held with them, the Associations have 3. requested for:

The verification fees may be paid by the OMCs for verification/re-verification of (i) dispensing units to the State Legal Metrology Departments. It may be paid manually as IGL is paying for CNG Dispensers.

Installation of flow-meters at retail outlets for decantation of petroleum products from (ii)Tank Lorries to ensure the correct quantity delivered to the RO dealers. However, as a pilot project, it may be initiated at three places namely Bengaluru. Chennai and Delhi.

(iii) SoP circulated for calibration of towers used for tank lorries calibration may invariably be followed at all places.

I would like to request you to kindly look into the matter and issue necessary instructions 4 to all concerned so as to ensure transparency and protect interest of all stakeholders.

Meeting held on 4<sup>th</sup> November 2016 at Hotel Marine Plaza between the Oil Marketing Companies, CIPD and AIPDA.

It got agreed as an interim measure as follows:

- An increase in Dealer Margin of approximately Rs. 138.00 per kL of Motor Spirit and Rs. 102.00 per kL of High Speed Diesel. The same shall be implemented on 15<sup>th</sup> November 2016.
- "Return of Investment" shall be studied by said joint committee of members from OMC, CIPD and AIPDA, to arrive at the component of "formulae".
- 3. Dealer Remuneration and earlier computational errors shall be examined & recommended for finalization by 15<sup>th</sup> November 2016 by the joint committee of members from OMCs, CIPD and AIPDA. The new dealer remuneration and the computational error, if any, amounts shall be included and increased in Dealer Margin in the next revision of dealers' margin.
- 4. The dealer margin shall be revised every 6 months on 1<sup>st</sup> January and 1<sup>st</sup> July of each year.
- 5. The revised NFA report shall be finalized by 30<sup>th</sup> November 2016 and implemented in the next revision of dealers' margin.
- 6. The man power study shall be commissioned by 31<sup>st</sup> Dec 2016 with an . external agency to be concluded within a period of 4 months.
- 7. The High Speed Diesel handling loss report shall be obtained from Indian Institute of Petroleum, Dehradun by 30<sup>th</sup> November 2016 and recommendations implemented in next dealer's commission revision.
- 8. Motor Spirit loss study shall be commissioned by 31<sup>st</sup> December 2016 and completed by 1<sup>st</sup> January 2018.

### CIRCULAR

### Sub: Revision of Safe Axle Weights for vehicles licensed under the Petroleum Rules, 2002 and Static and Mobile Pressure Vessels (Unfired) Rules, 2016-Reg

Ministry of Road Transport and Highways, (Transport Division) vide letter No. RT11028/11/2017-MVL dated 07/08/2018 conveyed that the permissible safe axle weight for different configurations of the axles of transport vehicles had been revised vide gazette notification S.O. 3467(E) dated 16/07/2018 and S.O. 3881 (E) dated 06/08/2018.

As a result of aforesaid notifications, the vehicle models which have been type approved before 16/07/2018 can be allowed for carrying additional pay load of petroleum or compressed gas as per revised maximum safe axle weights in any combination of axles in trucks, tractors and trailers subject to overall revised maximum permissible gross vehicle weight limits.

All the new models which are approved **on or after 16/07/2018** shall be tested for higher axle loads in force by the testing agencies authorized to issue type approval certificate under Rule 126 of Central Motor Vehicle Rules, 1989.

On perusal of above said letter of MoRTH, it is clear that the vehicles which are approved before 16/07/2018 shall not be once again tested for higher axle loads by the testing agencies authorized to issue type approval certificate under Rule 126 of Central Motor Vehicle Rules, 1989. However, Transport Departments of the State have to take necessary action to incorporate revised gross vehicle weights in the registration particulars of the transport vehicles.

In view of the above, the officers of Circle and Sub Circle offices of PESO prior to grant or amendment of license of petroleum road tankers or compressed gas mobile pressure vessels, shall ensure that the revised axle weights and gross vehicle weight are duly endorsed in the registration certificate by the transport department of the respective States. Further, mounting drawing shall be approved by Chief Controller of Explosives, Nagpur for revised maximum permissible safe axle weights for different configuration of axles of transport vehicles.

### Sub: Enhancement of Dealer Margin effective 30.10.24 Ref: Your letter dated 29.10.2024.

May we invite your kind attention to the letter cited at reference above wherein it is indicated that Dealer Margin has been increased to all categories of Dealers with emphasis on alleviating the hardship of Dealers where the throughput is less than 170 KLPM.

It is also indicated that all relevant factors of the Margin Component have been considered including such cost factors as E-Locking, VSAT/SDWAN and Loyalty Charges etc while calculating the revised margin.

The affirmation that the cost factors such as E-lock, VSAT/SDWAN and Loyalty Charges have been factored in the recent revised margin calculation provides information that these cost factors were being debited to the SOA/SAP accounts of the Dealers all these Years without making any provision in the previous margin calculation which in itself is a cost to the Dealer.

Dealer Fraternity has suffered utmost since 2016 when the **Demonetization** took place when we were used as catalysts to keep the wheels of economy moving. **Covid-19** saw volumes plummeting & Dealers faced the brunt when their Capital eroded due to non-recovery of Credit Sales & having to incur fixed costs in the form of Manpower cost, Electricity charges etc. Loss of lives of a few Dealers for failing to service the debt due to Bad Debts during Covid-19 crippled the confidence of the Dealers. During both these occasions Dealers have been in the forefront delivering the best of Customer Service Standard & keeping the flag of OMC's flying high without any compromise.

There has been a manifold increase in the cost of operating the retail outlet since the days of pre-revision of Dealer Margin 01.08.2017 due to Digitalization and Technological advancement. Having to absorb various costs out of the wafer thin margin it leaves very little for the Dealership.

We are well aware that the Dealer Margin Structure in three main components. **Fixed Dealer Margin Variable dealer Margin Differential dealer margin** 

#### 1. Fixed Dealer Margin

These are few components Return on capital investment / NFA (Net fixed assets) Returns of land and building, Returns of plant and machinery, Operating cost, dealer remuneration, staffs ,salaries.

### 2 Variable dealer margins

Returns on working capital, Product cost for MS and HSD, Product loss (evaporation).

### 3. Differential Dealer Margin.

We are getting reimbursement of our expenditures through our retail sales. Dealer remuneration is the only part we are getting as income (Net Profit). During the Mumbai meeting held on 22.2.2024, at Mumbai, entire association leaders asked to increase the dealer remuneration from Rs 27500/- for 170 KLPM to Rs 200000/- and include the new expenditures which the retail outlet dealers have to incur in present scenario to operate the outlet, which were never in existence a decade ago.

We have vide our letter dated 24.10.2024 requested for a meeting prior to the announcement of dealer margin. Much to our chagrin the Dealer Margin was announced to be effective from 30.10.24 without such a meeting taking place.

While the letter at reference above states that all relevant cost factors have been included in the revised Dealer Margin Calculation, as Your Channel Partner we may please be provided with the various costs which have been factored in the Dealer Margin. As you are aware a prudent businessman to be successful needs to be aware of the various costs one has to incur in operating his business.

We would like to know the break-up, because we have to operate the outlet within the amount what dealers will get. We request your good office to invite all the State registered Association and all the Registered National Association to brief us the latest working.

It is informed that, Shri K Sundaresan Deputy Chief Controller of Explosives & Head, South Circle, Chennai held VC meetings with State Heads( Retail) of OMCs- IOCL, BPCL, HPCL on 27/07/20, 28/07/2020 & 29/07/2020 and discussed thoroughbare, the safety & regulatory issue regarding **Bowsers/Refuellers-(Mobile Dispensers-DDD)**.

Subsequently, vide Memo dated 30/07/2020, PESO, Chennai emphasized and reiterated that dealers and DDD operators, of all the OMCs, shall comply with the provisions of Petroleum Rules in force, and if any violations brought to the notice of authorities, strict action will be initiated by the implementing authorities and OMCs against the erring dealers/DDD operators.
