#### TNPDA Achievement – 2023

# Round Table Workshop on Legal Metrology, Vigyan Bhawan, New Delhi

TNPDA, along with the State Petroleum Dealers Associations of Delhi, Rajasthan, and Gujarat, jointly met the Secretary, Ministry of Consumer Affairs, and discussed several long-pending issues related to petroleum retailing Legal Metrology.

#### Key issues presented:

- 1. Tower calibration
- 2. Tank lorry calibration
- 3. "K-Factor" of dispensing units
- 4. Verification stamping fees paid by OMCs
- 5. Product delivery at standard temperature
- 6. Underground tank calibration
- 7. Rounding off decimal digits in dispensing units
- 8. Vehicle tank fuel capacity approximation

The Hon'ble Secretary advised the Director, Legal Metrology, to convene a Round Table Workshop for addressing these concerns. Accordingly, the workshop was held on 09.06.2023 at Vigyan Bhawan, New Delhi, chaired by Shri Rohit Kumar Singh, Secretary, and Department of Consumer Affairs.

#### Resolutions Adopted

- 1. Tower Calibration Before calibration of the depot towers, OMCs will notify the Petroleum Dealers Association in advance to be present as witnesses, ensuring transparency. An SOP will be prepared by Petroleum Dealers Associations before 30.06.2023.
- 2. K-Factor Assurance Legal Metrology Officers will mandatorily mention the "K-Factor" of dispensing units in the verification certificate, providing an extra layer of assurance on dispenser performance.
- 3. Temperature Compensation in Invoices Invoices issued by OMCs for tank Lorries will include the real-time oil temperature and compensate against the reference temperature of 15°C. This ensures fairness, since fuel volume varies with temperature. As per the Legal Metrology (General) Rules, 2011, the Maximum Permissible Error (MPE) for vehicle tank compartments is 0.05% in excess of marked capacity.

இவற்றை கவனத்தில் கொண்டு, செயலர் சட்ட அளவியல் இயக்குநரிடம் வட்ட மேசை ஆலோசனையை நடத்த அறிவுறுத்தினார். அதன்படி, 09.06.2023 அன்று நியூடெல்லி, விக்யான் பவனில், நுகர்வோர் விவகாரத் துறைச் செயலர் திரு ரோஹித் குமார் சிங் தலைமையில் ஆலோசனை கூட்டம் நடைபெற்றது.

- 1. டெப்போ டவர் அளவீடு டெப்போ டவர்களை அளவீடு செய்வதற்கு முன், OMC-கள் பெட்ரோலிய விற்பனையாளர்கள் சங்கத்தை முன்கூட்டியே அறிவித்து, அவர்களை சாட்சியாகப் பங்கேற்கச் செய்ய வேண்டும். 30.06.2023க்குள் SOP (Standard Operating Procedure) பெட்ரோலிய விற்பனையாளர்கள் சங்கத்தால் தயாரிக்கப்பட வேண்டும்.
- 2. K-Factor உறுதி விநியோக இயந்திரங்களின் "K-Factor" தகவலை, சட்ட அளவியல் அதிகாரிகள் வழங்கும் சரிபார்ப்பு சான்றிதழில் கட்டாயமாக குறிப்பிட வேண்டும். இதன் மூலம் இயந்திர செயல்பாடுகளில் கூடுதல் நம்பிக்கை கிடைக்கும்.

Minutes of round table workshop on "measurement of petroleum products and related issues" held on 09.06.2023 under the chairmanship of Shri Rohit Kumar Singh, Secretary, Department of Consumer Affairs

A round table workshop on Measurement of petroleum products and related issues was held at Vigyan Bhawan, New Delhi on 09.06.2023 under the chairmanship of Shri Rohit Kumar Singh, Secretary, Department of Consumer Affairs. The list of participants of the workshop is attached at Annexure-A.

- 2. Shri Rohit Kumar Singh, Secretary, DoCA welcomed all the participants. In his inaugural address, he stated that the Department is actively pursuing integration of technology to replace human interfaces and blockchain technology is under consideration for credential management. He stated that Department of Consumer Affairs is committed to improving the ease of doing business & protecting consumer interests and such discussions & decisions mark significant progress towards these goals.
- 3. He also stated that this round table workshop has been an essential step in addressing significant issues in the measurement of petroleum products and Department is confident that the proposed solutions will pave the way for significant improvements in the industry. He stated that the decisions to be taken today are crucial for the industry's future growth and for the consumers who rely on these services. Key focus of the workshop was to improve transparency and simplify business operations in the realm of Legal Metrology.
- 4. Smt. Nidhi Khare, Additional Secretary, DoCA, provided a comprehensive overview on 'Measurement of Petroleum Products and Related Issues. She illustrated the extensive achievements, new initiatives, and strategic operations that the Department has implemented to promote the growth of the industry within the country. In her detailed presentation, she not only shed light on the Department's successful efforts and future plans but also candidly discussed the challenges encountered in fulfilling the Department's objectives.

- 5. During the workshop, several crucial issues were discussed in depth, including tower calibration at terminals, tank lorry calibration carrying petroleum products, "k" factor of dispensing units, verification fees paid to the Legal Metrology Departments for verification/ stamping of dispensing units, product delivery at standard temperatures, calibration of underground tanks at retail outlets, rounding off decimal digits of dispensing units, sealing of pulsar pumps and fuel tank capacity approximation of vehicles.
- 6. A notable outcome of the workshop was the decision to constitute a committee under the chairmanship of Joint Secretary (CA) with OMCs, OEMs, CLMs and Petroleum Dealers Associations. The committee is tasked with discussing pending issues in detail and recommending solutions that safeguard consumer interests at large.
- 7. Following Resolutions were adopted during the meeting:
- (i) Before calibration of Depot towers, the OMCs will notify the Petroleum Dealers Associations in advance to be present as witnesses to ensure transparency. An SOP may be prepared by Petroleum Dealers Association by 30.6.2023 to be vetted by OMCs before release.
- (ii) Legal Metrology officers shall mention the "k" factor of the dispensing unit in the verification certificate to provide an extra layer of assurance about the dispenser's performance. This "k" factor is a critical number that helps in understanding the flow rate or efficiency of a fuel dispenser.
- (iii) Invoices issued by OMCs for tank lorries will mention the oil temperature on real time basis and compensate it with the reference temperature of 15° C. This is important because the volume of oil can change with temperature. The MPE for Vehicle Tank compartment is 0.05 Percent in Excess of the Marked Capacity of the compartment as per the Legal Metrology (General) Rules, 2011.
- (iv) Automobile manufacturers to mention the safe filling capacity instead of the maximum filling capacity, which will help customers to make informed decisions and promote efficiency.
- (v) The correct/ full ambient temperature range of operation/ use of dispensing unit shall be mentioned on dispensing units by OEMs.

- (a) depositing verification/ stamping fees in advance by OMCs/ dealers
- (b) OEMs to provide rounding off in 3 digits in dispensing units
- © sealing provisions for tamper-proof dispensing units by OEMs, all the probable sealing point should be sealed, manufacturer shall provide all the sketch/ photos to Director and Controllers of Legal Metrology, where sealing is to be done
- (d) issue of repairing license in all States and outsourced repairing activities,
- (e) metallic transparent cover on electronics/ keypad of dispensing unit
- (f) use of mass flow meters on tank lorries to check the delivery at ROs
- (g) measurement of petroleum products of tank lorries at Depot with the same technology/ device (flow meter/ dip rod) which is used for decantation at ROs
- (h) consideration of verification of ATGs at ROs to cross check the stock in underground tanks
- (i) to issue a guideline for use of standard LPG/ CNG testing kits
- (j) the accuracy of tank lorry is 0.05% whereas proving measures used for calibration of tank lorries have accuracy of the order of 1%, which may be corrected.
- (k) for under ground tanks (UGT) at ROs the stock variation may be 4 % of tank capacity for variation; calibration of underground tanks with latest technology is required.
- (vii) Formation of a committee underscores the government's commitment to addressing the issues raised during the workshop under the chairmanship of Joint Secretary (CA). By bringing together key stakeholders such as OMCs, CLMs, OEMs and Petroleum Dealers Associations, the committee aims to develop comprehensive solutions that will enhance the operational transparency and efficiency of the petroleum products industry. The committee will examine all the pending issues illustrated above and submit it's recommendations within 3 months.
- 8. The workshop concluded with a vote of thanks to the chair.

Sir,

Kindly refer the 'Round Table Workshop' on 'Measurement of Petroleum Products' and related issues held at Vigyan Bhawan, New Delhi on 09.06.2023 under the Chairmanship of Shri Rohit Kumar Singh, Secretary, Department of Consumer Affairs to improve transparency and simplify the business operations within the realm of Legal Metrology.

- 2. During the meeting, the issue of calibration of depot towers was raised and it was decided that an SoP will be prepared by the Petroleum Dealers Association. A copy of the SoP submitted by Petroleum Dealers Association is enclosed herewith for needful.
- 3. It was also clarified by Petroleum Dealers Associations that the OMC's are the owners of Outfits and Equipment installed at Retail Outlets. It was requested that the existing procedure of 'Payment and Reimbursement' of Stamping fees may be discontinued due to delay in reimbursement of such fees. The Associations informed that the amount of stamping fees is considerably huge and the Dealers have to struggle to pay the same at the last minute. At the same time the Legal Metrology officers are also put to inconvenience while planning their visits to carry out the verification.
- 4. In the meeting it was requested that the OMC's may directly deposit the 'Stamping Fees' in advance for each of the quarter to Legal Metrology Department so that the Legal Metrology Department can plan their schedule of visits to Retail Outlets. It would also prove to be a time saving methodology for Legal Metrology Department.
- 5. It was suggested to initiate the said system as a 'Pilot Project' in the State of Tamil Nadu, as the database of the new online system has already been installed in Tamil Nadu and is functioning well. In this prevailing database formulated by LM Department of Tamil Nadu, no major modification is required, which may be done by the Government of Tamil Nadu. However, the updating of database in other State

may also be initiated and on its success in Tamil Nadu, the same may be implemented in other States.

6. Therefore, it is requested that the OMCs may initiate the process of depositing the verification fee online in the State of Tamil Nadu as a Pilot Project.

As you are aware, there are large number of dispensing units installed at Petrol Pumps/Retail Outlets for delivery of petrol/ diesel/ petroleum products. These dispensing units are periodically verified and stamped by the Legal Metrology Departments of the State Governments to ensure their accuracy.

- 2. In this regard, I would like to bring to your notice that various Petroleum Dealers Associations have represented to this department stating difficulties faced by them viz. payment of verification fees of dispensing units by OMCs, calibration of underground storage tanks/ tank lorries and adoption of uniform procedure for calibration of towers used for tank lorries calibration etc. A copy of the representations received is enclosed herewith for kind information.
- 3. In their representations and also in the meetings held with them, the Associations have requested for:
- (i) The verification fees may be paid by the OMCs for verification/re-verification of dispensing units to the State Legal Metrology Departments. It may be paid manually as IGL is paying for CNG Dispensers.
- (ii) Installation of flow-meters at retail outlets for decantation of petroleum products from Tank Lorries to ensure the correct quantity delivered to the RO dealers. However, as a pilot project, it may be initiated at three places namely Bengaluru, Chennai and Delhi.
- (iii) SoP circulated for calibration of towers used for tank lorries calibration may invariably be followed at all places.
- 4. I would like to request you to kindly look into the matter and issue necessary instructions to all concerned so as to ensure transparency and protect interest of all stakeholders.

TNPDA Achievement – Bogus Biodiesel Trade Issue (2018 onwards)

The Union Cabinet approved the National Policy on Biodiesel in 2018, a welcome initiative by the Government to encourage renewable fuel usage, reduce fossil fuel dependency, cut imports, and promote a cleaner environment. The policy also aimed to boost rural development by using Used Cooking Oil (UCO) as a potential feedstock for biodiesel, thereby preventing its diversion into the food industry. To further encourage this, additional tax incentives and higher procurement prices were offered.

However, in Tamil Nadu, many dealers reported a major problem: bogus biodiesel trade. A few individuals (not retail outlets) were illegally selling contaminated and substandard products in the name of biodiesel. These were distributed through mobile tankers at rates much lower than market prices. Unsuspecting consumers, attracted by the low price, purchased this adulterated fuel.

This malpractice badly affected our members (dealers), as it directly diverted sales and damaged consumer trust. Recognizing the seriousness of the issue, Tamil Nadu Petroleum Dealers Association (TNPDA) immediately represented the matter to the Joint Secretary, Ministry of Petroleum & Natural Gas, New Delhi.

Based on our representation, the Ministry of Petroleum & Natural Gas issued a strong circular letter to all Chief Secretaries of States and also marked a copy to the Oil Marketing Companies (OMCs), directing strict enforcement against illegal biodiesel trade.

Both the Ministry's letter and the OMC communication stand as proof of our persistent efforts. This intervention successfully protected our members' business interests and ensured regulatory vigilance against unscrupulous elements.

 $\Box$  Its is yet another significant Achievement of TNPDA in safeguarding dealers from unfair and illegal practices.

தமிழ்நாடு பெட்ரோலிய விற்பனையாளர்கள் சங்கத்தின் சாதனை – போலி பயோ டீசல் விற்பனை (2018 முதல்)

2018 ஆம் ஆண்டில் மத்திய அமைச்சரவை, நாட்டின் பயோ டீசல் கொள்கையை அங்கீகரித்தது. இது புதுப்பிக்கத்தக்க எரிபொருள் பயன்பாட்டை ஊக்குவிப்பதில், பாசிச எரிபொருள் சார்பை குறைப்பதில், இறக்குமதி செலவை குறைப்பதில், சுத்தமான சூழலை உருவாக்குவதிலும், கிராமப்புற வளர்ச்சிக்கும் உதவியாக இருந்தது. குறிப்பாக, பயன்படுத்தப்பட்ட சமையல் எண்ணெய் (UCO) மூலம் பயோ டீசல் தயாரிப்பு மேற்கொள்ளப்படுவதால், அது உணவு தொழில்களில் மீண்டும் பயன்படுத்தப்படுவதை தடுக்கிறது. இதை ஊக்குவிக்க கூடுதல் வரி சலுகைகள் மற்றும் அதிகமான கொள்முதல் விலைகளும் வழங்கப்பட்டன.

ஆனால் தமிழ்நாட்டில் பல மாவட்டங்களில் போலி பயோ டீசல் விற்பனை பெரும் பிரச்சனையாக உருவானது. சில الشراف (**விற்பனை நிலையங்கள் அல்லாதவர்கள்**) தரமற்ற மற்றும் கலப்படமான பொருட்களை "பயோ டீசல்" என்ற பெயரில், மொபைல் டேங்கர் மூலம் குறைந்த விலையில் விற்பனை செய்யத் தொடங்கினர். குறைந்த விலையில் கிடைக்கிறது என்ற ஆசையில் சில நுகர்வோர் இந்த பொருளை வாங்கினர்.

இதனால் எங்கள் சங்க உறுப்பினர்களுக்கு (டீலர்களுக்கு) கடுமையான பாதிப்பு ஏற்பட்டது. உடனடியாக, தமிழ்நாடு பெட்ரோலிய விற்பனையாளர்கள் சங்கம் (TNPDA), புதியதில்லி பெட்ரோலிய மற்றும் இயற்கை எரிவாயு அமைச்சகத்தின் கூட்டு செயலரிடம் இந்த பிரச்சனையை எடுத்துரைத்தது.

எங்கள் மனுவின் அடிப்படையில், பெட்ரோலிய மற்றும் இயற்கை எரிவாயு அமைச்சகம், அனைத்து மாநில முதன்மைச் செயலர்களுக்கும் கடும் எச்சரிக்கை சுற்றறிக்கை எழுதியது. அதேசமயம் எண்ணெய் நிறுவனங்களுக்கும் நகல் அனுப்பப்பட்டது, போலி பயோ டீசல் விற்பனையை கட்டுப்படுத்த கடுமையான நடவடிக்கை எடுக்குமாறு.

இரண்டு கடிதங்களும் (அமைச்சகமும் + OMC-களும் அனுப்பியவை) எங்கள் திடமான முயற்சிகளுக்கான சான்றாக நிற்கின்றன. இதன் மூலம் எங்கள் உறுப்பினர்கள் வணிக நலன்கள் பாதுகாக்கப்பட்டதுடன், சட்ட விரோதமாக செயல்படும் நபர்கள் மீது கண்காணிப்பும் வலுவாக்கப்பட்டது.

Sub: Bogus biodiesel trade - request for probe into

Sir.

The Union Cabinet approved the National Policy on Biofuels in 2018. This was a welcome initiative by the government in terms of encouraging the use of renewable fuel options, in the process cutting down on the use of fossil fuels. It seeks to reduce import dependency, facilitate a cleaner environment, gets farmers a better deal even during seasons of surplus production, and encourages investment for infrastructure development in rural areas. As used cooking oil is a potential feedstock for biodiesel, its use to make biodiesel will prevent its diversion in the food industry for reuse. Additional tax incentives and higher procurement prices have been offered.

Indeed, biofuels are of strategic importance in India as it aligns with several ongoing initiatives of the government such as Make in India, Swachh Bharat Abhiyan, and Skill Development. The policy offers significant opportunities to meet the ambitious targets of doubling farmers' incomes, reduce imports, boost employment generation, and use waste to create wealth.

However, the Tamil Nadu Petroleum Dealers Association would like to draw the kind attention of the Union government that a few people (not retail outlets ,through small tankers/ bowsers) are selling in the name of biodiesel, contaminated and inferior material that does not meet the standards set. Some unscrupulous elements are selling products through tankers at rates that are lower than the market rates. Some consumers, lured by these rates, are purchasing the product,

Such activity is vocative of the Central Excise and VAT and GST rules, among others, and affects the legal trade. The deleterious effects of such bogus products on vehicle engines are noticed eventually, but by then it is often too late.

There ought to an investigation by the Central government, possibly through the Central Bureau of Investigation, into this illegal activity, which is evidently backed by an organized network of suppliers and distributors – who are also generating unaccounted money in the process. The originating points of the material need to be identified first. To avoid these illegal activities, Petroleum Ministry can instruct, Public Sector Undertakings Companies to market the product to maintain the SOP. We look forward to appropriate action.

You may be aware that this Ministry has issued notification dated 30.04.2019 on the subject "Guidelines for sale of Biodiesel for blending with high speed diesel for transportation purposes-2019" (copy enclosed).

Point no (x) of the said Guidelines states that State Government authorities shall have the power to carry out regular inspections of the retail outlets selling biodiesel to ensure that the biodiesel is being made available to the customer in the right quality and quantity, and is not being sold as a standalone fuel for transportation purposes.

Furthermore, point no (xii) of the said guidelines states that to ensure that the Retail Outlets of Biodiesel are selling only Biodiesel conforming to BIS Standards State Government officials are empowered to inspect, search and seize unauthorized and unscrupulous Biodiesel manufacturing plants, the storage and distribution units and Retails Outlets.

The above mentioned notification was sent to all States/ UTs vide this Ministry's Letter dated 06.05.2019 (copy enclosed) for taking appropriate action.

Recently this ministry has received several complaints regarding sale of unauthorized product in the name of Biodiesel for transportation and industrial purposes. This unauthorised sale of product is not only a safety hazard but also a revenue loss to Central/State Governments by way of various taxes.

I therefore, request you to look into the matter and issue necessary directions to curb the menace of such unauthorized sale.


